

Transportation

On January 16, 2021, an agreement was signed to enhance cooperation in the vital transportation sector. This agreement supports sustainable development efforts, including infrastructure development such as roads and railways, and the exchange of expertise to develop human capabilities

Electricity and Energy

On February 19, 2023, discussions between Minister Mohamed Shaker and Deputy Minister of Energy Ahmad Khadjaev focused on opening new investment opportunities and cooperation in electricity, renewable energy, and energy efficiency.

Health

On May 9, 2023, Minister of Health and Population Khaled Abdel Ghaffar met with the Ambassador of Uzbekistan Mansurbek Klyshev to discuss collaboration in combating hepatitis viruses and other health initiatives. This included building capabilities, training medical staff, providing medical and therapeutic supplies, and enhancing medical tourism.







Pharmaceutical

On February 19, 2023, the Chairman of the Egyptian Pharmaceutical Authority hosted a delegation from the Pharmaceutical Industry Development Agency of Uzbekistan. They discussed regulatory work to enhance trade exchange in medicine and medical supplies, including an inspection tour of regulatory authority laboratories to facilitate advanced accreditation from the World Health Organization.

Trade, Industry, and Investment

On February 20, 2023, Minister of Trade and Industry Ahmad Samir received the Deputy Prime Minister of Uzbekistan and his delegation, including Minister of Investment, Industry, and Trade Laziz Kudratov. They discussed improving trade exchange rates and enriching joint industrial and investment cooperation, noting a 7% increase in trade from USD 46 million in 2021 to USD 49.9 million in 2022.

Tourism

On August 31, 2022, the Ambassador of Uzbekistan in Cairo confirmed that tourism is a major area of cooperation, with Egypt being a favored destination for Uzbeks. Charter flights between Tashkent and Sharm El Sheikh have been operational since 2019, with regular flights between Sharm El Sheikh and Tashkent. Efforts are ongoing to boost tourism cooperation, including the participation of Egyptian tourism representatives in the International Tourism Exhibition in December 2022.







Education

On February 20, 2023, Minister of Higher Education and Scientific Research Ayman Ashour met with Uzbek Minister of Higher Education, Science, and Innovation Ibrokhim Abdurakhmonov to discuss cooperation in higher education and scientific research. They emphasized accommodating Uzbek students in Egypt and fostering academic exchanges between universities.

Agriculture

On August 27, 2023, Minister of Agriculture and Reclamation Al Quseir met with the Ambassador of Uzbekistan in Cairo to explore trade exchange opportunities in the agricultural sector, following agreements made by the presidents of both countries.

Textile

On February 19-20, 2023, a delegation from Uzbekistan visited Egypt to discuss deepening cooperation in the textile industry. Discussions included the establishment of a showroom in Cairo for Uzbek textile products and the potential for Egyptian textile workers to move production facilities to Uzbekistan.







Planning and Economic Development

On September 26, 2021, the Ministry of Planning and Economic Development, led by Minister Dr. Hala El Said, engaged in talks with Uzbek Deputy Prime Minister for Investment and Foreign Economic Affairs Dr. Umurzakov Oktamovich. They explored potential business opportunities and discussed rural development initiatives.

In addition to these governmental agreements, seven MOUs were signed between Egypt's private sector and the Uzbekistan government, covering industries such as tourism, aviation, pharmaceuticals, electronics, textiles, and more.



Flexible Economy suitable for investment

Uzbekistan, located in Central Asia, has emerged as one of the fastest-growing economies. Its strategic geographic location and abundant natural resources, combined with a strong commitment to economic reforms, make it a prime destination for investment and collaboration.

Egypt and Uzbekistan have shared historic, cultural, and educational relations since 1992, when diplomatic ties were first established. These relations have laid the foundation for robust economic trade and investment partnerships.

Egypt's strategy to enhance collaboration with Uzbekistan has been clear, particularly following President Abdel Fattah El-Sisi's visit in 2018 and the subsequent visit by Uzbekistan President Shavkat Mirziyoyev in February 2023. Accompanied by key ministers from trade, investment, health, tourism, culture, and energy sectors, these visits highlighted the distinguished relations between our countries in all fields. Numerous agreements and discussions have been held to further deepen this cooperation across various sectors:

Summary guide to invest in Uzbekistan

The business environment in Uzbekistan offers streamlined registration processes, various tax regimes, and a liberalized currency regulation policy aimed at fostering economic development and attracting foreign investment.

- Choice of Organizational-Legal Form Options include Limited Liability Company (LLC) and Joint Stock Company (JSC).LLCs offer flexibility and ease of creation, preferred by both foreign and national entrepreneurs. JSCs are suitable for larger businesses planning to distribute shares among the population. Early consultation with a lawyer is advised to ensure effective organization and compliance with national law.
- Tax Regimes: The General Tax Regime imposes various taxes including value-added tax, income tax, and social tax, with rates varying based on activities and sectors. Special Tax Regimes cater to specific categories of taxpayers, offering exemptions, reduced rates, and other benefits.
- **Currency Regulation:** significant liberalization measures in its monetary policy have been undertaken to attract foreign investment. Settlements are predominantly conducted in the national currency, with exceptions for projects with foreign investments. Foreign direct investment transactions have minimal restrictions.
- Free Economic Zones (FEZs) offer a golden opportunity for investors seeking high returns in a dynamic economy.

Tax Incentives: significant tax exemptions for up to ten years.

Streamlined Procedures: simplified administrative processes, ensuring a hassle-free setup and operation.


Infrastructure Access: strategically placed hub in the Central Asian region, well-developed infrastructure, transportation networks, offers opportunities for companies looking to expand into new markets. **Diverse Opportunities**: wide range of investment opportunities in industries like logistics, mining, agriculture, electronics, and textiles.


- Emerging Tech Ecosystem: it's IT Park represents a promising venture into nurturing the country's burgeoning tech ecosystem. With a focus on supporting startups and IT companies, it provides an ideal environment for innovation to flourish.
- Intellectual property (IP) rights, reflected in its legislation and international agreements. The protection of IP stimulates innovation, attracts investment, and aids in the development of national producers. The Department of Intellectual Property oversees regulation, with copyright automatically granted upon creation and patents requiring registration.
- Cybersecurity, a law enacted in 2022 addresses the growing digital threats. Critical information infrastructure is defined, and the State Security Service is tasked with cybersecurity regulation. Responsibilities include incident reporting and compliance with cybersecurity standards. State support aims to enhance legal frameworks, provide tax benefits, and promote education and funding.
- **Cryptocurrencies**, it's embracing digital assets with regulatory frameworks overseen by the National Agency for Prospective Projects. Crypto-assets are property rights managed through licensed service providers, with specific activities like mining and exchange subject to regulation and licensing. The tax regime is favorable, and a regulatory sandbox facilitates innovation.
- The country offers a **judicial system** and alternative dispute resolution (ADR) options for investors. The judicial system includes various courts, and ADR methods like mediation and arbitration offer efficient dispute resolution. The choice of ADR method depends on factors like the nature of the dispute, cost, and enforceability. Understanding these options is crucial for investors navigating legal matters in Uzbekistan.







Regarding the Health Sector, Following the meetings with the Vice Prime Minister and the investment minister, a new era of cooperation in medication and health materials is opening.
