



Memorandum of Understanding

Preamble

In pursuit of strengthening relations and fostering mutual cooperation, Malaikah, the Egyptian Angel Investor Association, and the Egyptian Council for International Cooperation (ECIC), a non-profit organization committed to promoting economic and business relations between Egypt and other nations, have agreed to form a joint Entrepreneurial and Investment Committee. This committee aims to develop and promote Egyptian businesses and startups in emerging frontier markets.

Malaikah, as the leading angel investor association, and ECIC, dedicated to international cooperation, (hereinafter referred to as the "Parties"), conclude the following Memorandum of Understanding to establish a practical framework for the committee's development and define the roles, responsibilities, and goals of each party.

The Parties will establish an Entrepreneurial and Investment Committee to enhance bilateral economic and business relations by exploring new market opportunities and ensuring successful collaborations for the development of Egypt an startups and businesses.

Article Two

Malaikah will head the Entrepreneurial and Investment Committee, taking responsibility for leading initiatives aimed at fostering entrepreneurship and investment in Egyptian businesses, particularly those targeting emerging frontier markets.

Article Three

Article Four

Article Five

The Parties will work together to organize business and economic conferences, as well as trade missions, to highlight the investment potential in Egyptian startups and emerging frontier markets. Representatives from various sectors, government agencies, and ministries may also participate to foster greater cooperation.

Article Six

Malaikah and ECIC will promote among their networks the committee's projects and initiatives, ensuring active participation and support from the Egyptian and international business communities.
